Revised PCA framework for banks issued by RBI on 2nd November 2021, the RBI reviewed all existing PCA framework for all scheduled commercial banks and revised them, under the new and revised framework, Capital, Asset Quality, and Leverage will act as the key areas for monitoring, the provision of the revised framework will be in works from January 1, 2022. The RBI first introduced the PCA framework in December 2002 as a structure early-intervention mechanism to supervise and regulate the banks that become undercapitalized due to poor asset quality and management. The regulations were revised in April 2017.
